- II. Brief Reports/Introduction of Resolutions:
 - A. Council Delegate, Dwight Witherspoon
 - 1. The meeting with Army Corp Engineer at Hardrock Chapter on October 14th
 - Request to the Chapter Officials to identify the locations of check-dams, tributaries, etc.
 - Local visitations: 8-11am at Forest Lake Chapter 11-1pm at Black Mesa Chapter
 - 2. Water Rights Negotiation Team is standstill with the Hopi Tribe.
 - 3. Dzilyijiin Region Police District meeting at Window Rock on October 24th; Support is needed from all Dzilyijiin chapters.
 - 4. A concern expressed by Chapter Administration on Gaming Revenues; the payment to NTUA was very slow and a few times, the utilities were almost shut off; need a better procedures in place for payments made with Gaming Revenues. Mr. Witherspoon recommends purchasing solar panels for the chapter house and recommending having assessment be conducted.
 - 5. He received updates from the Chapter Officers on North Valley Power Line Extension Project.
 - 6. Council Fall Session starts on October 17th.

Comments and Concerns made by Chapter Officers:

- Wells Fargo Online Banking Services DCD and auditor general demands and not treating chapters
 as local governments. The chapters that owe large amounts to IRS should be the ones signing up
 with Wells Fargo. Forest Lake Chapter is already experiencing discrepancies with the funding
 reports.
- 2. Funds from Peabody Western Coal Company Black Mesa Chapter are utilizing the funds for power line extension project and would like to continue receiving funds to complete the projects. Oak Ridge is in Phase IV of the Manymules Waterline Extension Project and the people will not see it happened. All funds will be depleted before Phase IV.
- 3. He recommends to request to RDC for funding.

- C. CSC, Albert Lee No reports but submit a list of people requesting for chapter assistances; He made deposit of FY 2017 funds.

 - 1. She conduct home visit to her clients for 4 days per week.
 - 2. The assigned tribal vehicle is out of service and is at shop for repairs and services. She is using her own vehicle and does not get reimbursement for mileage. She spends most of her time in the office doing her paper work.
 - 3. She was requested to submit the list and number of community members who are high risk and elders. The purpose is for community emergency preparation and readiness.
 - 4. She was informed that she can request to NDOT and/or BIA Road Maintenance for road improvements for her clients and elders.

 - 1. He informed the community members that public coal will be open on October 24, 2016.
 - 2. Javis Williams of Peabody Coal Company was planning to attend the chapter meeting but will now need to inform him of reschedule of the meeting.

 - 4. Coal Card issue One person living in mine lease area objects to issue coal cards to people living outside the lease area which is not right and unfair.

III. Updates on Chapter On-going Projects:

- A. N8066 Road Construction, Phase III & Permanent Bridge
 - 1. Tentative meeting with Delegate Leonard Pete and Sharon Yazzie for updates on the progress is scheduled on October 12, 2016.
- B. N8065 Low Water Crossing Project
- C. North Valley Power Line Extension Project
 - 1. NTUA are staking out the lines for main trunk lines for the project.
 - 2. Updating the documents with the budget need to be continued.
- D. Black Mesa Head Start Building
 - 1. A pre-construction meeting was held on Tuesday, 10/4/16 at the BM Chapter.
 - 2. The construction is projected to cost about \$1.6 million. The building will contain two classroom.
 - 3. There were about 20 people from different entities such as Navajo DES, Navajo EPA, Arviso Contractors and their subcontractors, LAM Corporations, Navajo OSHA, Navajo Water Code Office, and NTUA.
 - 4. A walk through of the site was conducted to determine the location of office and fencing with entrance.
 - 5. Part of the dirt on the North of the Chapter House is being considered for hauling to fill the ground work on site of the head start building. The concrete slabs might be used but will be tested for asbestos. Trash dumpster needs to be relocated to the South of the Chapter House.
 - 6. Local dam water, chapter water and sewer lagoons are being considered to be used for construction. Approval of letter or chapter resolutions is need.
 - 7. The cost of extension/transfer of electricity from a pole to head start building will be paid by the Chapter Administration. The cost might be up to \$19,000.
 - 8. NN OSHA gave information about the regulations and compliances relating to construction. Proper PEP is required within the construction zone. They can provide training.
 - 9. Ground work will start on Monday; putting up fences; and Northwest entrance will be closed.

Navajo Nation President Begaye line-item vetoed about 17 items. NN Council is now questioning the valid of his veto power since he was in Washington DC when he signed the documents. The Navajo Law requires that NN President has to be on Navajo Nation to use his veto power.
