- 3. Response to Mr. Witherspoon's statement on "not enough funds" to keep up with requests.
 - NDOT is getting most of the BIA Road Construction Funds and eventually Construction Section of BIA Roads Dept will phase out. They will go through "Reduction In Force" process.
 - These funds are being used more for hiring administrators which causes less of funds to do any road improvements (not enough operators).
 - Funds are being used for NDOT appreciation dinners/events and a lot of travels to out-of-state conferences.
- 4. Heavy duty truck (hauling trucks) are destroying the paved roads, making cracks.

 - 1. Brief updates on BM Head Start Building and N8066 Road Construction projects.
 - 2. Dzilyijiin Regional meeting on January 8, 2015 at Pinon Chapter.
 - 3. Navajo Hopi Land Commission meeting with House Appropriations Committee Field Hearing on January 24, 2015. The Committee met with some community members of HPL, New Lands and Bird Spring on many issues such as lacking of infrastructures and the needs of Navajo relocatees and HPL families and Bennett Freeze area.
 - 4. Naa'bik'iyati Committee Meeting on January 22, 2015 Re-appointing Levon Henry as Chief Legislative Counsel.
 - 5. NN Council special session Selection of Standing Committee of NNC. He got selected for Budget and Finance Committee and is Vice Chairman of the Committee.
 - 6. \$1.5 million allocations from Peabody Western Coal Company The Committee is recommending to allocate all of \$1.5 million towards Manymules Waterline Project for Phase III Allocations.

Concerns by Chapter Memberships:

- Navajo Scholarship Office is delaying payment for student tuitions and causing late fees being added on to their tuition costs. These late fees are not covered by Navajo Scholarship Office. There needs to be some actions conducted soon by NN Council Delegates.
- 2. Navajo Nation should plan for set-aside funds for scholarship program to avoid what is happening right now.
- 3. Why can't NN negotiate with colleges on late payment fees to avoid extra fees (late)?
- 4. The sight of culverts by washes makes you think of what happened to all Navajo Leaders. These washes should have been repaired by now, but no action is being seen.
- Recommending not to invest \$554 Million Settlement funds; the community needs are here. A lot
 of people do not have running water or electricity for their homes. Majority of the roads are not
 paved.
- 6. Navajo Nation Trust Fund is already in the Bank earning interests and it can't be touch for any needs of the Navajo people.

Mr. Witherspoons' Responses:

- There is current discussion by Speaker of NNC and Budget/Finance Committee on proposing a Transportation Stimulas Act for the Navajo Nation.

- C. Grazing Committee Member, Francis Honie
 - 1. Navajo Nation Livestock Program requires ID tags for all livestock of the Navajo Nation. For more information, contact Chinle or Ft Defiance offices.
 - 2. A resolution requesting the NN DOJ to give more authority to Grazing Officials has been submitted.
 - 3. A home site lease will be required for all homes.
 - 4. A revision is being recommended for Tally Count Guidelines.
 - 5. No action on cancelled grazing permits and still conducting interviews for local livestock owners.
 - 6. Most chapters have submitted resolutions requesting some changes to current NRIA but no actions yet by Navajo Dept of Agriculture.
