Purpose, which states, "Through adoption of this Act, the Navajo Nation Council delegates to Chapters governmental authority with respect to local matters consistent with Navajo Law, including custom and tradition,"; and
2. The BLACK MESA CHAPTER Community Land Use Plan (CLUP), according to CAP-34-98, 26 N.N.C and certified by N.N.C, TCDC on July 28, 2005, fully supports the construction of the Black Mesa Chapter Veterans Organization; and
3. The BLACK MESA CHAPTER Veterans Organization fully supports the construction of the Black Mesa Chapter Veterans Organization Facility to empower them to address and promote their needs for benefits, health, education, housing, and employment promptly without any restraints or hindrances and to help them recapture their independence with their civilian livelihood; and
4. The BLACK MESA CHAPTER has listed the Veteran's facility as number (1) on their facility construction priority list, and all clearances have been completed; and
5. The members of BLACK MESA CHAPTER acknowledge and honor the service and sacrifice our Veterans have made for the Navajo Nation and our Country. With complete support for their efforts, the construction of this facility will encourage and empower our Veterans to identify the challenges they endured as Veterans in civilian life.
